

Water Hardness in Your Area



It has been brought to our attention that the Stratmoor Hills Water District community has seen an increase in water hardness over the past 6 months. The District completed our new water treatment plant in April of 2022 and we have now made the switch to using our three groundwater wells to meet the majority of our daily demand. Previously we received a majority of our water from the

Fountain Valley Authority, which is treated surface water. Currently, the FVA is undergoing major repairs and is not in operation until March 2023. Therefore, we must rely on our groundwater rights to meet the daily demand. Groundwater tends to be harder than surface water and can range to greater than 1000 mg/L. What are the known sources of water hardness? Water hardness in most groundwater is naturally occurring from weathering of limestone, sedimentary rock and calcium bearing minerals. We understand that you may be experiencing harder water than before, but please rest assure that the District is treating your water to the highest standards established by the Colorado Department of Public Health and Environment. If you are experiencing hard water, we ask that you look into possible treatments, such as water softeners. A home water softener is the most efficient way to remove the minerals that make your water hard. Affordable water softening systems are available from a variety of retailers with capacities to fit your home's water usage and hardness. Your water meets or exceeds all State and Federal regulations required for a public water system.

Why So Many Main Breaks and Outages??

We have received several comments and inquires regarding the amount of water outages the District has experienced. There is one main reason for this... "AGE". The overall age of our infrastructure is almost 70 years. It cost the District \$150,000 to \$200,000 a year to replace only a small portion of pipeline. We also have small field crew that can respond to these disruptions in the system. We understand that these outages are an inconvenience, but we respectfully ask for your patients and understanding. We will do everything possible to restore water in a timely manner.


SANTA IS COMING TO TOWN!!!!!
