NATIONAL DRINKING WATER WEEK

The week of May 2nd—8th has been declared National Drinking Water Week. For more than 40 years the American Water Works Association (AWWA) and its members have celebrated Drinking Water Week – a unique opportunity for both water professionals and the communities they serve to join together in recognizing the vital role water plays in our daily lives. Please join AWWA and the Stratmoor Hills Water District as we celebrate drinking water! This year the theme is "There when you need it".



Stratmoor Hills relies on snowpack in the Colorado Rockies to provide us with a reliable drinking water supply. Our primary source of water comes from the Frying Pan Arkansas (Fry-Ark) water supply. Much of this water comes from the Arkansas River and is stored in Pueblo Reservoir. From there, it is pumped to the Fountain Valley Water Authority water treatment plant (Just South of Fountain) where it is treated to meet all Safe Drinking Water Act standards. The water is then pumped to the District's water storage reservoirs so that it is available to meet the needs of our customers.

Our second source of water comes from the Widefield Aquifer. The District has three wells that are used primarily in the summer to meet the higher water demands. With the discovery of Perfluorinated Compounds (PFCs) in the aquifer, the district conducts extensive sampling of our well water to ensure that the concentration of these compounds are below the State's health advisory level. Even though our untreated source water did not exceed the health advisory level last year, we added Ion Exchange treatment at our wells to remove PFCs to levels below detection. Our groundwater is extremely valuable to the District and it is important to protect this source from any contamination.



Outside Electrical Work

- Have a qualified electrician do all electrical work.
- To prevent an electrical shock, make sure all your outside electrical receptacles are GFCI (groundfault circuit interrupter) protected.

Equipment Safety

- Use lighting and power tools that are listed by a qualified test laboratory and make sure they are made for outdoor use.
- Store your electrical tools indoors.
- Keep electric tools away from children.
- Keep the area around your electric meter and other electrical equipment clear.
- Check lighting and extension cords for damage before using. Replace any damaged cords right away.
- Use extention cords that are listed by a qualified test laboratory and are marked for outdoor use.
- Extension cords are not meant for long-term use.

POWER LINES

Have a professional tree cutting service trim branches that might fall on electric wiring. Use a wooden or fiberglass ladder outside. Keep the ladder at least 10 feet away from power lines. Never touch anyone or anything in contact with a downed wire. Power lines may be live, stay a safe distance away. Report downed wires to authorities right away.

IMPORTANT REMINDER

Call "Before You Dig"
(8-1-1) before any digging on your property. They will mark where your underground utilities are located. It's a free service!
