

Our Mission Is To Provide Safe, Clean, Reliable Drinking Water

Over the past few months, the Stratmoor Hills community has been experiencing harder water than normal. In November 2022, the Water District stopped receiving surface water from our partnership with the Fountain Valley Authority. The FVA was shut down for 4-5 months to perform several major maintenance projects. Based on the FVA outage, the District has been completely on groundwater since November. Groundwater is typically a lot harder than surface water because of naturally occurring limestone, sedimentary rock and calcium bearing minerals. The District has been treating the groundwater to all State and Federal Regulations, but there still has been some issues with water hardness.

However, we have some good news to share. The District will be going back to supplementing our groundwater with treated surface water in late April or early May. The FVA will be back in operations this Spring and the Water District will start mixing our groundwater with the FVA treated water to help mitigate some of the hard water issues. Although this change should help reduce the hard water issues, hard water may still be present going forward. If you have concerns with hard water issues, we recommend checking into a water softer to help eliminate

water hardness.

Lithium-ion batteries supply power to many kinds of devices including smart phones, laptops, e-scooters and e-bikes, e-cigarettes, smoke alarms, toys, and even cars. If not used correctly, or if damaged, these batteries can catch on fire or explode.

The problem

- These batteries store a large amount of energy in a small amount of space.
- Sometimes batteries are not used the right way; batteries not designed for a specific use can be dangerous.
- Like any product, a small number of these batteries are defective. They can overheat, catch fire, or explode.

Safety Tips

- Purchase and use devices that are listed by a qualified testing laboratory.
- Always follow the manufacturer's instructions.
- Only use the battery that is designed for the device.
- Put batteries in the device the right way.
- Only use the charging cord that came with the device.
- Do not charge a device under your pillow, on your bed, or on a couch.
- Do not keep charging the device or device battery after it is fully charged.
- Keep batteries at room temperature when possible. Do not charge them at temperatures below 32°F (0°C) or above 105°F (40°C).
- Store batteries away from anything that can catch fire.

Signs of a Problem

Stop using the battery if you notice these problems: odor, change in color, too much heat, change in shape, leaking, or odd noises. If it is safe to do so, move the device away from anything that can catch fire. Call **94-1**.

Battery Disposal

- Do not put lithium-ion batteries in the trash.
- Recycling is always the best option.
- Take them to a battery recycling location or contact your community for disposal instructions.
- Do not put discarded batteries in piles.

Charging an E-bike

Charge your battery in a flat, dry area away from children, direct sunlight, liquids, tripping hazards, and in a location where the e-bike is not at risk of falling.
